

**RESOLUTION NO 02-2021**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CANYON, TEXAS, ORDERING A GENERAL ELECTION TO BE HELD ON THE 1ST DAY OF MAY 2021, FOR THE PURPOSE OF ELECTING FIVE (5) MEMBERS OF THE CANYON CITY COMMISSION (MAYOR PLACE 1 AND PLACES 2, 3, 4 AND 5); DESIGNATING POLLING PLACES; ORDERING NOTICES OF ELECTION TO BE GIVEN, AUTHORIZING EXECUTION OF JOINT ELECTION CONTRACT; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, in accordance with the general laws and Constitution of the State of Texas and the Charter of the City of Canyon, Texas, a Municipal Officers' election is to be held on the first Saturday in May; and

**WHEREAS**, it is necessary that the City Commission of the City of Canyon order (**Exhibit A**) an election to be held on the 1<sup>st</sup> day of May 2021, 7 00 a.m. to 7 00 p.m., for the purpose of electing Commission members for Mayor Place 1 and Places 2, 3, 4, and 5 at large, and

**WHEREAS**, the election shall be held as a Joint Election administered by the Randall County Elections Administrator in accordance with the provisions of the Texas Election Code, the Charter of the City of Canyon, and a Joint Election Contract with the County of Randall with costs for the election to be allocated amongst all entities contracting with Randall County Elections, and

**WHEREAS**, the City of Canyon accepts Randall County Election Administration's use of the direct recording electronic voting system, which have been certified by the Secretary of State in accordance with the Texas Election Code and approved by the United States Department of Justice.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CANYON, TEXAS.**

**SECTION 1**

That a Municipal Officers' election is hereby ordered for May 1, 2021, for the City of Canyon, Texas, for the purpose of electing members of the City Commission for Mayor Place 1 and Places 2,3,4, and 5 Randall County Vote Centers for the election will be at the following locations.

The listed Randall County Voting Centers shall be open between the hours of 7:00 a.m. and 7:00 p.m. the date of the election. The election will be conducted in accordance with the Joint Election Contract by and between the City, the County of Randall and other units of government and the Texas Election Code.

## **SECTION 2.**

That the City Secretary is hereby directed to cause notice of said election to be published at least once, not earlier than the 30th day nor later than the 10th day, before election day as provided in Section 4 003(a) (1) of the Texas Election Code; and shall be posted on the bulletin board used for posting notices of the City Commission meetings not later than the 21st day before election day. A copy of the published notice that contains the name of the newspaper and the date of publication shall be retained as a record of such notice, and the person posting the notice shall make a record at the time of posting stating the date and place of posting in accordance with Texas Election Code Section 4 005

## **SECTION 3.**

That early voting by personal appearance by any qualified City of Canyon resident may be conducted at the Randall County Voting Centers as follows.

**SECTION 4.**

That applications for early voting ballot by mail shall be mailed to Shannon Lackey, Early Voting Clerk, Randall County Elections Department, 1604 5th Ave, Canyon, Texas 79015 Applications for early voting ballot by mail must be received no later than the close of business on Tuesday, April 20, 2021

**SECTION 5.**

That if a run-off election becomes necessary, the Randall County Elections Administrator will conduct the run-off election to be held to be determined by date of official canvass.

**SECTION 6.**

That in accordance with Section 123 001 of the Texas Election Code, the Direct Recording Electronic Voting Systems approved by the Secretary of State are hereby adopted for the election on May 1, 2021

**SECTION 7**

That the City Secretary is hereby authorized to execute a Joint Election Contract for the conduct of a joint election to be held on May 1, 2021, and to approve any amendments thereto

**SECTION 8.**

That the first day to file an application for a place on the ballot with the City Secretary is January 13, 2021, at 8:00 a.m., with the last day for filing to be February 12, 2021, at 5:00 p.m., in accordance with the Election Code Sections 143 006 and 143 007

**SECTION 9**

That pursuant to the Joint Election Contract, the Randall County Elections Administrator shall serve as Election Administrator for the election. Presiding Election Judges and an Alternate Presiding Election Judges appointed to serve at said polling places shall be those election officials furnished by the Elections Administrator from the list of proposed election judges listed in an attachment to the Election Contract.

**SECTION 10**

That in compliance with Section 271 006 of the Texas Election Code, Shannon Lackey, Randall County Elections Administrator, will be appointed as Early Voting Clerk. Other deputy early voting clerks will be appointed as needed to process early voting mail and to conduct early voting by personal appearance at the branch locations.

**SECTION 11**

That an Early Voting Ballot Board shall be created to process early voting results in accordance with Section 87 007 of the Texas Election Code. The Early Voting Ballot Board shall be made up of members appointed in the manner stated in the Joint Election Contract and the Presiding Judge and Alternate Presiding Judge of the Early Voting Ballot Board shall be the election officials listed in the Joint Election Contract.

**SECTION 12.**

That should any word, sentence, paragraph, subdivision, clause, phrase or section of this resolution be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said resolution, which shall remain in full force and effect.

**SECTION 13**

That this resolution shall become effective immediately from and after its passage and is accordingly so resolved.
